

RENEWAL OF QUALICOAT APPROVALS IN 2024

To renew a coating material approval (P-No.), powder manufacturers must submit expeditiously **two out of the three colours** specified below to a QUALICOAT testing laboratory, from January and **not later than 31 May 2024**.

If the system has a metallic extension, RAL 9006 needs to be sent in additionally.

All ΔE values specified above are final limits after the weathering test (see Appendix A12 of the <u>QUALICOAT Specifications</u>). Colour tolerances before granting or renewing an approval are listed in Appendix A8 of the Specifications.

If the required colours are not part of your standard production, samples need to be produced especially for the tests.

Since every approved system must be continuously exposed in Florida, powder manufacturers with approvals granted during the first two months of the year (basic colours exposed from April 2024) must also submit renewal colours before 31 May 2024.

If a powder manufacturer fails to submit the required colours to the laboratory on time and if no panels are sent to Florida consequently, two of the colours and one metallic colour will be banned in accordance with section 4.2.4 of the QUALICOAT Specifications.

New certificates valid for one year are issued in December of each year based on the Florida test outcomes of the previous exposure year and on the results of the laboratory tests completed during the current year (renewal tests, extension of an approval, retesting of banned colours).

To renew an approval for powder-on-powder (P/P), **powder manufacturers must submit powders (base and top coatings)** for the tests prescribed in § 5.2.1 of the QUALIDECO Specifications to be carried out on the following decorations:
